

FROM THE DESK OF THE GRAND PATRIARCH

As your newly installed grand patriarch, I have the pleasure and the responsibility to lead Pennsylvania encampments over the next year. While I happily except this charge, I realize that leaders are only successful when they have a vision and effectively communicate that vision to their members. Encampments across the commonwealth, our great country, and the world, are all faced with the specter of declining membership. This places a greater burden on those who remain to continue the works of our order. While we all work to build our membership base, we need to stay vigilant not to let the works of our order erode. It is said that Friendship, Love and Truth are stronger when supported by Faith, Hope and Charity. My charity for this year is Feeding America. Feeding America is the largest charity working to end hunger in the United States. They partner with food banks, food pantries, and local food programs to bring food to people facing hunger. They advocate for policies that create long-term solutions to hunger. In the United States, 1 in 11 face hunger and, 1 in 8 of those are children. Feeding America keeps administration costs under

1%, so 99% of donations fund the vision of the organization. Food banks in Harrisburg, Westmoreland, Erie, Nazareth, Ducane, Philadelphia and several others across Pennsylvania support local community programs. \$2.5mm are distributed through SNAp generating 4mm in overall effectiveness. It is challenging to believe that we have people going hungry when we waste Billions of poundspounds of food every year. I believe when we find solutions to hunger, we create a stronger community. This environment is conducive to building our membership. How you ask. When people don't have to worry on where their next meal is coming from, they are able get involved. They can participate in organizations like odd fellows because it is these organizations that have helped them.

While this may not be a direct membership drive, it is my hope, my fellow patriarchs and odd fellows will support my vision. I have faith, that together, we can make hunger a topic of the past while supporting and growing our great fraternity. Thank you.

VINCENT LODGE CELEBRATES THE SUMMER







523 MONUMENT



At around 235 acres, Grandview is one of the largest cemeteries in Pennsylvania. Members of Alma Lodge and William F. Packer Encampment, of Johnstown, place IOOF Flags and holders in this cemetery, as well as the marker shown, placed by Conemaugh Lodge before they consolidated with Alma Lodge. MORE FOOD FOR THOUGHT ????

Well, I finally got around to replying to Byron Goldstein's article in the August issue of this magazine in which he states that scholarships, grants, awards, etc. that students receive and are NOT sent directly their respective colleges, universities, and schools of trade, causes him distress.

He sites a sound example of a student who qualifies for \$15,000 in financial aid from a college. He states that if a lodge or group sends the college an award check on behalf of the student, for let's say \$1,500, the college will, in just about every case, deduct the \$1,500 from the financial aid the college provides. So, the award does not really benefit the student because of the negative affect resulting from the reduction of the financial aid

Mr. Goldstein, being an independent college admissions counselor for over 20 years, probably deserves to be called an "expert" when dealing with such matters. In fact, we spoke many years ago about this same issue, and he strongly encouraged me to follow his suggestion(s). I told him, at the time, that I would present the Board of the Odd Fellows and Rebekahs Association of Western Pennsylvania with his suggestion at our next meeting. Several weeks later, and after some discussion among the Board members, it was unanimously decided that we continue with the procedures that we have followed since the inception in 2006 of our awards, that being to send our scholarship award checks directly to the schools, unless there are extenuating circumstances.

This issue has been discussed by our Board several times over the past 10 years or so, and the discussions always ended with the "If it ain't broke, don't fix it!" decision.

Our policy is to make contact with the Financial Aid Office/ Bursar's Office/ Student Accounts Office prior to sending the school an award check. In only ONE instance, over the past 18 years, did an official from an office as such indicate that a particular student was close to the threshold for an award to have a negative affect on the financial aid the student was scheduled to receive. In that particular case, a check was sent directly to the student.

In notifying and congratulating the student that he/she has received an award, they are also informed that their award check was sent to their college/university and placed into their account in such a manner as to supposedly not affect any financial aid, grants, scholarships, or awards that they may have already received. It is requested that if the student becomes aware of any changes in the financial aid they were to receive, to please contact us immediately so that we may hopefully remedy the situation. "Knocking on wood," this has not happened with either the undergraduate or the graduate scholarship (instituted in 2016) programs.

In our correspondence with each of the schools receiving the award checks, we specifically request that the check be "placed in the student's account in such a manner as to not affect any financial aid, grants, scholarships, or awards that the student may have previously received." If there is a possibility that our request can

not be honored or that an award check will be jeopardized in a negative manner, the check is to be returned and a new check would be issued directly to the student. If I may take this opportunity to enlighten the reader as to a few incidents which have occurred over the past few years that justifies why we send our award checks directly to the recipient's schools.

A student received a \$4,000 award for a school year and dropped-out completely after the first semester of his junior year. The school had a policy of dividing the award amount evenly between two semesters, fall and winter/spring, unless otherwise specified. A \$2,000 refund was issued to the Association midway through the 2nd semester. Had a check been sent directly to the student, I doubt it if any refund would have been considered.

Another student who received a \$4,000 award was involved in a program of studies which required her to take the 1st semester of her sophomore year for on-the-job training to make sure her decision to enroll in such a program was to her liking. She would not be enrolled as a full-time student during her semester of training, therefore having no required tuition payment. She continued with the program the 2nd semester of that school year. We received word of such from the Director of Financial Aid and a refund of \$2000 was issued,.

An incident, not school related, occurred several years ago regarding our local IOOF lodge. We received word that a young lady from a nearby town was seriously injured in a sled-riding accident and medical bills were mounting. Our lodge decided that it would be an excellent idea to make a monetary donation of \$2000 to be used toward her medical bills. Several months after such a donation was made and acknowledged, and an almost complete recovery for the young girl, we heard "through the walls" that the girl's parents supposedly used the donation money for a trip to Disney World.....and did not take the daughter with them! Hearing this left a bad taste in our mouth regarding giving donations directly to individuals. (We did not follow-up on the situation because a denial would have been undoubtedly expected,)

So, with all due respect to Mr. Goldstein, I understand his reasoning regarding the sending of award checks to the directly to the student or family, but our Association feels comfortable and justified that our "way" of handling award checks benefits each student as intended and we will continue to do so until the need to change may come about. Hope this article does not cause him, or any one else, any more distress and I wish him the best and continued success as a college counselor.

Note: We are "fortunate" to only have the small number of recipients like we have had over the years because I don't know how Mr. & Mrs. McHugh, in running the outstanding Odd Fellows and Rebekahs of PA Scholarship Program, would be able to handle all the student & school correspondences with the large number of awardees that they have every year.....but I am sure they would be able to figure out a way!!!! And, yes, their scholarship checks go directly to the students.

On October 1, 1928, George Peppard, an American actor, was born in Detroit, Michigan (d. 1994). On October 2, George "Spanky" McFarland, American child was born in Dallas, Texas (d. 1993). On October 21, American Baseball Hall of Fame pitcher Whitey Ford (NY Yankees), born in NYC. New York.

Halloween is always October 31, and in 1928 this was on Wednesday. The usual trick or treat takes place on a weekend. With Halloween in the middle of the week, things happened both the weekend before and weekend after. In advance of the rock group, people were smashing pumpkins for several weeks. Although the Model A was out, most people still owned Model T's and other "open" cars. It became necessary to check your car seat before you sat down. A familiar sight was a raccoon feasting on pumpkins along the side of the road.

Elizabeth's younger sisters, Mary and Virginia, were still interested in trick or treating, and went on Wednesday, October 31. Vic had managed to put a collar on Melchizedek. Mary and Virginia were dressed as Arabs and, after a few bites and a little fighting they got Melchizedek into what, more or less, looked like a camel costume. They started out the evening with a saddle bag on the raccoon, to carry the treats. After about three stops, they found he was eating the treats as fast as they could gather them. Mary and Virginia reverted to carrying their own bag, but they had to give bits of cookie to Melchizedek to keep the camel from running off.

Vic had been a man of many talents and photography was one of them. He thought his daughters looked too cute, he took several pictures (back and white, on film) as they started going through the town of Grovers Mill. The whole town was amused and Mary and Virginia were rewarded with many treats. Their brother John was dressed as a lion tamer and had a lion outfit on the Spitz dog. The camel was more successful than the lion.

The Odd Fellow Lodge had arranged for hot chocolate and cookies for the trick or treaters on Wednesday. Barney and Elizabeth had been assigned the job of making the cocoa and keeping order. This was not difficult till the raccoon and dog both arrived

and were competing for treats. You probably know what a raccoon looks like. A Spitz is a white dog and a picture can be found here: https://en.wikipedia.org/wiki/Spitz. The Spitz was about the same size as Melchizedek. Because they were both on leashes, they were kept apart.

Children like to get treats. Sometimes they become demanding. Dogs and raccoons are more difficult than children. When Vic came to collect his children at 8:30 pm, he was surprised at the barking. What made him more surprized was that some of the children had poured bowls of cocoa and the raccoon and dog (named Sinner) were lapping them up. Vic tried to explain to the children that it was unwise to give chocolate to raccoons and dogs. He finally go the kids home.
